

Notice Inviting quotations for hiring of goods vehicle for transporting KCCPL manufactured products to various locations for 6 months

KCCP Limited invites quotations from prospective service providers to provide 01 (one) < 3000 kg goods carrier (Mahindra & Mahindra or similar make vehicles in Diesel engine category) not more than 5 years old well-maintained to be used up to 26 days per month and 3000 kms per month, on hiring basis for a period of 6 months as per terms and conditions mentioned in this notice.

Terms & Conditions

1. The quotationers should submit the self-attested photocopy of all the documents along with application. The application will be received at the office of the undersigned on all working days within office hours up to 06.11.2024 2.00 PM.
2. The copy of this notice as well as the specific format for quoting rate, both will be available at company's website. The quotationers must sign each page of this notice and specific format for quoting rate and submit in a sealed cover with Q No. KCCP/QUOTATION/1548/2024-25 date on the top of the envelop to the office of the undersigned upto 2.00 P.M. of 06.11.2024 after which no quotation will be entertained. The quotation will be opened in the same date i.e on 06.11.2024 after 4.00 P.M in presence of the quotationers or their authorized representatives who will be available at that time. A bid may be called for on the same day in presence of intending quotationers if reasonable rate is not arrived.
3. After acceptance of the lowest quotation, the successful quotationer must have to execute formal agreement with the company on a stamp paper worth Rs.200/- and by depositing a token Earnest money of Rs.1,000/- only in the form of cash which is refundable after expiry of contract period.
4. The quotationer shall have to bear expenditures for all kinds of washing, repairing, servicing, supply of spare parts for repairing of the vehicle etc.
5. All kind of taxes must be paid by the quotationer.
6. The vehicle will have to be replaced immediately by another diesel vehicle of same specification without any extra cost, if the earlier car becomes unserviceable due to break down or any other causes.
7. The vehicle must be in good condition and with commercial permit. It may be placed for servicing once in two months at the own cost of the supplier and fitness certificate should be produced to the undersigned in regular course.
8. The payment will be made in favour of the quotationer on the basis of the bill submitted. Payment will be made as per availability of fund.
9. While payment of bills, statutory deductions such as TDS as per IT/GST Act will be deducted at the rates applicable at that time.
10. The contract may be terminated with a one month notice from either end.
11. All disputes arising out of this quotation will be settled in the Court of Cannanore
